TERM AND CONDITIONS OF BRPL FAN REPLACEMENT AND REBATE SCHEME:

I, _____, resident of _____ (hereinafter referred to as "consumer"), consumer of BSES Rajdhani power limited (hereinafter referred as "BRPL") through SPD connection of RC namely _____ having its address as _____

_____ do hereby affirm and state that I understand that BRPL purely to facilitate its consumers and under the terms of DSM based Super Energy Efficient BLDC FAN Program in UT of Delhi "Program", has launched the FAN REPLACEMENT AND REBATE SCHEME "scheme" whereby BRPL is giving the platform to leading manufacturing companies to sell their Super Energy Efficient BLDC Fans (hereinafter referred to as "BLDC Fan") under the terms of program at a concessional price to its consumers under the direct Sale-Purchase relationship between the consumers and BLDC FAN manufacturing companies and no role of BRPL. I being the consumer through SPD connection, out of my own accord, have agreed to enter into a direct sale-purchase relationship with the manufacturer of BLDC FAN. I confirm that I am in compliance of the terms of this undertaking and shall adhere the same, in full, as recorded below:

1. That I have received a valid Registration number for availing the scheme and have fulfilled all the relevant criteria for availing the scheme as enumerated below for which relevant proof shall be provided in case of further verification at the time of installation/:
 - 1.1 I have provided a self-attested copy of valid ID proof such as passport, voter ID, driving license, Aadhar card, PAN card, or any other valid photo ID proof and also provided a certificate issued from SPD registered consumer confirming the sub-connection of electricity in my favor for the premises for which the scheme is proposed to be availed.
 - 1.2 I have provided a valid address proof of occupation as owner or legal occupant at the premises in BRPL area in terms of regulation 10(3) of the DERC (Supply Code and Performance Standards) Regulations, 2017.
- I agree that, without prejudice to what has been provided under law, in case of doubt as to the correctness and/or validity of document, the decision of BRPL shall be final and BRPL shall be well within its right to disentitle the consumer to get the benefit under the program/scheme and the decision of BRPL shall be final and irrevocable.
- 1.3 I have no outstanding dues against the sub-connection of electricity on which the scheme is being availed, as on date of Registration and all outstanding dues have been cleared to SPD/RC.

- 1.4 Consumer has installed the new BEE 5 star rated BLDC Fan/s at the premises where a functional, running fan (if BLDC FAN is purchased under Replacement), not having any star rating as per BEE 2019-star labeling, which will be exchanged to avail the rebate on the scheme.
- 1.5 Electricity to the consumer is being supplied through same sub-connection of electricity through SPD/RC on which benefit of the scheme is being sought to be availed. Scheme is applicable for First come First Serve basis.
2. After Availing the scheme, I shall abide by all the following conditions enumerated as below:
 - 2.1 I shall render all assistance necessary for an installation/removal of the existing non star old fan at its premises and bear the necessary cost for the same where required other than standard removal if BLDC FAN is purchased under Replacement.
 - 2.2 I shall use and ensure BLDC FAN purchased under BRPL FAN replacement scheme is used for domestic purpose only at the address enrolled in scheme.
 - 2.3 I shall permit BRPL representative or any third party so authorized by BRPL to visit my premises for the purpose of monitoring and verification of the BLDC FAN for a period up to 3 years from the date of installation at the premises.
 - 2.4 I shall not remove, relocate or transfer the BLDC FAN unit purchased under this scheme outside the premises enrolled under this scheme.
 - 2.5 I shall not transfer, sell, lease, rent out or otherwise use the BLDC FAN bought under this scheme for commercial purpose.
 - 2.6 I shall not physically transfer the BLDC FAN availed under this scheme shall to any other person under any circumstances for a duration of 3 years from the time of installation.
 - 2.7 I shall be under a mandate to secure a permission, in writing, from BRPL prior to the BLDC FAN is removed from the premises or transferred within 3 years from the date of purchase. The consumer understands that the consumer is availing the BLDC FAN under DSM based Super Energy Efficiency FAN Program in UT of Delhi, duly approved by DERC and accordingly, confirm that in case of removal and/or transfer of BLDC FAN from the premises within three years and/or any non-compliance of the terms of this instant undertaking by consumer, BRPL shall be having full right to recover the full rebate amount availed by eligible consumer under the scheme by any suitable mechanism as deemed fit by BRPL. Further, in the event BLDC FAN is relocated from the address enrolled for the scheme, the warrantee offered under this scheme shall be withdrawn/discontinued.
 - 2.8 I agree that manufacturer shall be solely responsible in case of any defect, deficiencies in after sale services or in the product quality or performance availed under the scheme, any such issues, complaints, disputes arising thereon, BRPL shall in no way be responsible, liable for the quality, performance of the product and after sale services to be provided by the manufacturer, dealer etc.
 - 2.9 I agree and confirms that BRPL in no manner endorses the quality, performance of the product (BLDC FAN) or manufacturer's claims on the product and is relying upon the market research and other product surveys so produced by the manufacturer/dealers only.
 - 2.10 I confirm and agree that I shall be responsible for the safe keeping of the BLDC FAN and take reasonable, prudent step to ensure running of the BLDC FAN in normal conditions. I shall be held responsible for any damage to the BLDC FAN caused by any negligent act, failure to exercise due care etc.
 - 2.11 The offered price under the scheme quoted by the OEM shall cover the cost of BLDC FAN, the salvage value of unit to be exchanged (fixed rate) in case of Replacement and the cost of installation along with three years warranty on the unit depending on make and model of the offered BLDC FANs. Any installation expenses beyond the standard installation rate and market practice are to be covered by the consumer at his/her own expenses.
 - 2.12 The consumer do hereby agree and undertake that in case of failure and/or non-compliance by the consumer of the terms of this undertaking and/or initiation of any legal proceedings and/or imposition of any penalty/cost/liability/damages and any other liability/directions of any nature leading to any penal or other consequences, relating to the purchase and/or use of BLDC FAN by the consumer, under the BLDC FAN replacement and rebate scheme, the

consumer shall be unconditionally and unequivocally liable to indemnify BRPL in full including litigation expenses and agree that no legal action by consumer and/or its associate against BRPL shall be maintainable before the court of law, citing any ground whatsoever.
